MINUTES OF THE ANNUAL GENERAL MEETING OF NATURE LONDON FRIDAY, FEBRUARY 16TH, 2024 This was a hybrid meeting

Prior to the official start of the meeting, Don Taves, President of Nature London, read the following land acknowledgement:

"We are gathered today on the traditional lands of the Anishinaabek, Haudenosaunee, Lunaapeesak and Attawandaron. The three Indigenous Nations that are neighbours to London are the Chippewas of the Thames First Nation; the Oneida Nation of the Thames; and the Munsee Delaware Nation who all continue to live as sovereign Nations with individual and unique languages, cultures and customs. This land continues to be home to diverse Indigenous whom we recognize as contemporary stewards of the land and vital contributors to our society."

1.0 Call to Order

Don called the 2024 Annual General Meeting to order at 7.30pm. Thirty (30) members constitutes a quorum. There were 51 members in attendance — 40 in person and 11 via Zoom.

2.0 Minutes of the 2023 Annual General Meeting

The minutes of the 2023 Annual General Meeting were posted on the Nature London website prior to the meeting for members to read.

Motion: It was moved by Cathy Quinlan and seconded by Gordon Neish: That the minutes of the February 17th, 2023, Annual General Meeting be approved as presented. Carried

3.0 2022-2023 Annual Report

The Annual Report is a comprehensive report of the happenings within Nature London over the past year. Don thanked Gordon Neish for putting the report together and all the volunteers who contributed. The report was posted on the website prior to the meeting for members to access.

Don gave a snapshot account of the report and encouraged everyone to read it emphasizing that we are a vibrant and busy organization.

4.0 Financial Report

The unaudited Financial Statements to August 31st, 2023 were also posted on our website prior to the meeting . Lesley Pergau, Treasurer, presented the report and reported that Nature London is in a sound financial position.

As of August 31st, 2023 our assets/liabilities were as follows:

The Board allocated \$15,000 for our Eco-Grants program in 2022-2023. \$14,315 was actually spent.

Our cash in hand as of December 31st, 2023, was \$239, 214

Lesley Pergau and Bernie VanDenBelt answered questions from the membership about the Solar shares, endowments, and the London Community Foundation. Motion: It was moved by Lesley and seconded by David Wake: That the 2022-2023 Financial Statements be adopted. Carried

5.0 Bequest from the Turner Estate

Nature London has received a bequest from the Turner Estate in the amount of \$110,000. Don presented the following for information purposes only and noted that no action is required at the present time:

- Dr. Katherine Turner previous President of Nature London
- Residuary Gift to Nature London in her Will \$110,000 received to date.
- Invested in short term GIC's.
- Discussions held within Nature London Board and the Nature London Finance Committee
- Exploratory meeting with the London Community Foundation re options for the funds including the use of endowment funds.
- Offered to circle back with the Turner family with our preliminary considerations.
- Upcoming gift from the Attridge Estate

6.0 Review Engagement

In past years we have dispensed with an external audit, but it is proposed to conduct a Review Engagement for the 2023-2024 fiscal year ending August 31st, 2024. This is now required as Nature London is a Public Benefit Corporation whose revenue is more than \$100,000 but less than \$500,000 for the fiscal year 2023-2024. The reason for this extra revenue is the bequest from the Turner Estate.

The fee for a Review Engagement will be somewhere between \$3,500 and \$5,000.

By having a Review Engagement, we are in compliance with the Ontario Not-For- Profit Corporations Act (ONCA). This resolution requires a majority of at least 80% to pass and, if passed, only applies to the current year.

Motion: It was moved by Gordon Neish and seconded by Kathleen Holland: That the members of Nature London resolve that the Corporation undertake a Review Engagement for the year ending August 31st, 2024. Carried

Motion: It was moved by Glenn Berry and seconded by Ric Symmes: That the Nature London Board of Directors be authorized to select a qualified accounting firm to undertake the Review Engagement. Carried

7.0 Approval of Revised By-Laws

Gordon Neish (Past President) explained the reasoning for the revised By-Laws. Nature London Inc. is incorporated as a nonprofit under Ontario's Corporations Act which was replaced by Ontario's Not-for-Profit Corporations Act (ONCA) on October 19th, 2021. We and other existing non-profit corporations have until October 19th, 2024 to bring their governance documents into conformity with ONCA. Apart from complying with ONCA, this also provides us with an opportunity to review and update our governance documents.

The new bylaws were developed by the Bylaw Subcommittee of the Board of Nature London Inc. with substantial support from Community Legal Education Ontario's (CLEO) Benjamin Miller and CLEO's bylaw builder.

A draft was made available prior to the AGM to Nature London members for review and comment. The Bylaws were approved by the Board. At this AGM approval is needed by a two-thirds majority of the members

Questions were raised by the membership regarding the start date of appointees and the Board of Directors (last sentence in Appendix of the By-Laws) and also the start/end dates of membership (Section 6 of the By-Laws). Gordon responded by saying the By- laws are not written in stone and can still be reviewed, finetuned and changed by the membership at any AGM. Also, any tweaks that may be needed can be addressed in our Procedures Manual. It was agreed that the last sentence in Appendix A be deleted and that the Board will look at the start/end dates of memberships.

Motion: It was moved by Susan Berry and seconded by Sandy Symmes: That the Revised Bylaws be approved as amended. Carried

8.0 Articles of Amendment

Form 5271E Articles of Amendment, Not-for- Profit Corporations Act, 2010, along with our current Letters Patent dated March 17th, 1972, and our Supplementary Letters Patent dated June 10th, 2021, will constitute Nature London Inc's Articles.

Again a two thirds majority was needed to approve this change.

Motion: It was moved by Glenn Berry and seconded by Kathleen Holland: That Nature London members authorize the Board to proceed with the filing of the Articles of Amendment. Carried

9.0 Election of Directors

Don noted that 3 members of the Board are stepping down either through resignation or because their term has come to an end. Bob Wright resigned effective January 5th, 2024. Elizabeth Bell and John Berry will end their terms effective August 31st, 2024. Don thanked these members for their work and commitment during their terms in office.

Don announced that Brienna French will be joining the Board effective September 1st, 2024. Brienna introduced herself to the membership

Don declared the state of candidates for the 2024-2025 Nature London Board of Directors elected by acclamation.
